

## **2024 Financial Highlights**

The following are financial highlights from the 2024 Ministry year.

- December General Fund giving was extraordinarily strong at \$518k, bringing full year giving to \$2,848k, \$240k over budget and 13.1% over 2023.
- Missions directed giving came in at \$44k for the full year against a plan of \$50k, and \$42k in 2023.
- Spending continued to come in under budget, totaling \$2,595k, \$59k under budget for 2024 and \$141k below 2023.
- The General Fund surplus is \$297k for 2024 against a plan of \$4k, bringing the General Fund Balance to \$622k, excluding the Building Fund transfer discussed below.
- Building Fund giving was \$25k in 2024, compared to project spending of \$34k, bringing the ending fund balance to a deficit of \$93k. To cover the shortfall, we have transferred \$100k from the General Fund.
- Benevolent Fund giving was \$36k against expenditures of \$31k, bringing the ending fund balance to \$48k.
- Year-end Cash balance for all funds is \$577k. We have no debt.

## 2025 Budget Highlights

- The 2025 budget includes a 5% increase in compensation for all staff, excluding recent hires.
- Staffing includes current levels plus one full-time administrative person for general office duties and purchasing.
- Ministry budget reflects submissions from leaders, with significant changes to current programs to include prayer ministry (\$14k) and two student ministry leaders (\$24k).
- Missions budget continues our current mission commitments plus \$12k for Recovery Church, which was included in Benevolent Fund giving in 2024.
- General Fund Giving required to support the planned spending is \$2,813k, a 1% decrease compared to 2024.
- The Building Fund projects for 2025 include replacing the boiler in Greenland (\$105k), repaving the parking lot in Raymond (\$48k), and a new camera system for tech. ops (\$53k), plus additional necessary projects.
